

## The Law of Life 2 – Common Law

Humans go through free will checkpoints cyclically, at least every 2000 years. At that time, more intensely than usual, the collective consciousness of man or the public sphere, the shadowy sides of our society are deliberately shown, with which they 'stab' into the naive, dormant consciousness of man and put him before a decision: Will he use the new information to gain insight into the state of affairs, open a third eye of spiritual vision and chose responsibility over themselves... or neglected the information, fell even deeper into ignorance and under the control of artificial intelligence.

The Laws of Life are <u>immutable</u> Laws of Life that are <u>untouchable</u> by human hands. They are the inseparable, interwoven foundation of the <u>Great Law of One</u> that leads to an understanding of how this world works. All beings of light must conquer it, because spiritual progress or evolution of consciousness rests on it. Without an understanding of the Law of One or Common Law, we have no proper basis for light propagation and lose the capacity for spiritual sovereignty.

Natural or Universal Law is a law taken from nature, it is not an abstract law, created from an abstraction from Life-separated thought, according to which human society now operates. It applies to everyone regardless of beliefs or behaviors about it... just like gravity works on you whether you believe in it or not, whether you know about it or not.

The Common Law summarizes that <u>all organic beings are sovereign and completely</u> <u>free</u>, that knowingly or unknowingly they make decisions of their own free will in all circumstances.

Common Law springs directly from the realm of Oneness and transcends the world of duality and human law. While the world of things is neutral and acquires the connotation of positivity and negativity only in the hands of man, depending on whether he uses things to increase himself or to increase the common good..., the Nature of consciousness is basically benevolent, feeling and loving and is not impartial to pains and sufferings of man.



The highest expression of Love, from which Common Law derives, is freedom. Freedom is the most harmonious arrangement of personal energy, it is a state of health, it is harmony with the Law of One and the foundation of spiritual sovereignty.

Being <u>unawakened</u> in awareness of Common Law, is a choice that diminishes the glow of consciousness, and with it clarity, discernment, and independent judgment, creating spiritual addiction, confusion, distress, disease, and all kinds of deprivation.

Spiritual sovereignty is growing into the realization that I don't need leaders, to rule me, with this knowledge being the starting point that must lead into a behavioral transformation, with which I show increasing compliance with the Laws of Life, more self-awareness, that I have the right judgment, to stop myself from harmful behavior and I don't need external laws, rules and punishments for not doing them.

Non-awareness creates the perfect platform for all possible suffering, distortions and non-compliance with the Laws of Life. Unconsciousness is separate awareness, it is the rule of belief that man stands alone. This is the lowest vibrational level. From it, even if he doesn't want to, man works against everything and everything and creates more and more inconsistencies, which he will have to recognize, experience and abandon if he wants The Life.

For the higher level to reveal itself to you, to allow you to enter it and receiving its powers, you need spiritual sovereignty, maturity for self-responsibility and self-control.

Control does not mean military discipline, but the complete relaxation of being from no-mind, from an inner silence in which there is nothing to control. It is a surrender to the loving flawlessness of Life, it is a trust in the Order and Logic that governs It, and which convinces everyone of its intelligent benevolence, if only one silently attends to the life of nature and experiences it with one's body.



## Responsibility

The first emphasis of Common Law is, that everyone is fully responsible for their own actions and inactions.

The indigenous peoples lived and taught the Common Law as the foundation of culture, and it could be summed up in a simple moral rule: "Do not do violence to another being", not physical violence, not by interfering with the spiritual intimacy and freedom of another. When violently, which is without his awareness and consent, we interfere with another being, we create a disharmony of energies, we are immoral. A morally awakened being therefore rises to the level of Love, which embodies freedom and respects intimacy, the spiritual sovereignty of another.

The guiding force of the <u>Universal Law of One</u> is this simple, yet mysterious morality of <u>non-invasiveness</u>, which is precise and infallible in judging how far we cross its threshold. Non-interference with the freedom of others is therefore a fundamental law of Common Law, and any violation of it causes unfavorable consequences. But it doesn't end there, inaction can also create negative consequences.

Our level of existence skillfully hides from us the importance of respecting the free will of others and <u>teaches</u> us to interfere with it, thereby creating offense after offense against the Common Law and a level of extremely low brightness from which the breakthrough to freedom is greatly hindered. From this starting point, it is the inactions that have a greater negative effect for us.

Example: Let's say we find out how corrupt governments are, how selfish interests they have in relation to people, that they know and even cause unfavorable living conditions and use horrible methods to keep the collective consciousness at the lowest possible frequencies. And let's say that we are once again at the free will check point and are these, often very disturbing, revelations necessary to awaken us to the recognition of that dark side of our world, which we do not pay attention to or do not believe in our leisurely, self-absorbed lives? Suppose the revelation was undeniable, recognized by your body, and the changes outside of you are so dramatic that you can't help but take a closer look?

This is exactly what happened in the time of Jesus, He was a revelation, the greatest revelation of all time, for He who is the Life, the Truth and the Way became incarnate in the region of death, which was a miracle attended by all the



cosmic races, in order to show us with His High Being how the ruling elites fear the Light of Consciousness and what they are willing to do to suppress it.

The same as then, we have a choice again now: will the shock shake us, collapse the false mental construct of "successful civilization" and send us like phoenixes into the self-rule of loving demigods... or into denial, defense of our trapped thoughts and into complete control of mindless mechanical technology.

For someone to be able to digest the dark truth of our world, he must recognize denial as the weakness of unlove and be at least that much with himself, to do his own research before finally giving in to denial and is sincerely committed to clarifying the matter.

So that he does not reject the revelations without personal engagement. Love works by sacrificing, fear compels, love informs and enlightens, fear conceals and obscures.

The decision whether to obey fear or love is always yours.

Humans choose denial and self-deception over clarity and knowing because our lack of understanding of the immutable Laws of Life gives us an apparent leeway to bend the rules our way. The fundamental goal of the thought at this level of existence is to obscure the Common Laws and create the conditions for indiscernment and indiscretion. Due to ignorance of the energetic nature of life, we are weak, independent, fearful and immature, inclined to create safeguards around our low psychophysical complex of energies, with which we instinctively protect ourselves against any threat that could shake it.

## Sharing gifts

Another emphasis of Common Law is responsibility for implementing the knowledge received.

This tells us that until we know, we are responsible for the laziness and negligence of not wanting to know. When we learn about the Common Law and about a certain higher behavior and, despite knowing, do not live it, we become fully responsible for this choice. Ignorance was man's protection before Jesus (hence the measurement of time before and after Christ), when he had no 'credible' spiritual beacons that could regulate his behavior, but after Him the perfection of Life worked tirelessly, so that everyone learned about Him and ignorance could no longer be a means of evasion.



We are now standing on the threshold of clarity that Life is not to be trifled with; if you know something, you have to live it.

## The golden rule of Common Law

Let me also mention the golden rule of Common Law, which everyone knows in the 2022 years since it was given to us: "Do unto others as you would have others do unto you." This is the simplest form of all 12 Laws of Life, which presupposes the divine starting point of a man, who cannot imagine behavior harmful to Life. Therefore, when we enter the spiritual or physical intimacy of another, without his/her consent, we create for ourselves and for the collective disharmony, unconsciousness, disease and death, which have hardened over thousands of years into an immoral dark cloud of collective ignorance and indifference that embraces the Earth and our light bodies.

Thus, we can correctly say that ignorance is the only source of evil, because it makes one think that there is no Authority or Law higher than that written by man.

As long as we are still in a state of neglecting anything, denying... such as the shadowy, often indigestible sides of our society for a pure person..., as long as we are still in the area of the unconscious, we are creating favorable conditions for the preservation and increase of evil.

Therefore, apathy, indifference, finding excuses, indulging in cowardice, is not... from an energetic point of view, only a dangerous situation for person, but for the collective consciousness and is a multiplied offense against Love and Responsibilities for one's actions in relation to other beings.

Jesus pointed out that the soldier who obeys the orders of his superiors will be judged less severely than the one who gives orders after killing, because he taught obedience, but the soldier is not entirely irresponsible, because he could choose otherwise, even at the cost of his own life.



You can't blame anyone for not making an effort to raise your personal vibration and to take responsibility for your own actions, because energetically there are no external orders to obey that would justify your inconsistent actions. This is the great illusion of this level of existence.

Common Law has zero tolerance for ignorance.

It is the great irony of free will that ignorance, in the Nature of Life, in which everything you need is already within you, is also a choice. Those who don't know, want so.

Common Law as you now see is the summation of Love, which is the inner Ruler of every living being, and cannot act violently against any other being. It is the very own nature of the Living, among which each of them will be included or excluded from them by their own actions. For those of you who want Life, your next step is crystal clear:

- love yourself and forgive yourself delusion... or in other words
- be true and you will become a Light to yourself.

If you take this crucial step, you will be able to leave behind all those beliefs, habits, environments and people with which you have tied yourself to the world of darkness... and begin co-creating the Golden age of humanity. In this case, your Shine will be Eternal.
